Please read the following and share with your group before your arrival at the Omni New Haven Hotel at Yale.

- No throwing objects from stairs/balcony.
- No hanging from railings or sliding down banisters.
- No loud TV or music in public areas.
- Food brought in from the outside, may not be consumed in public areas; it must be consumed in your room.
- The following are not permissible:
- Alcoholic beverages, any form of tobacco products, illegal drugs

- Firearms, knives, or any other kind of weapons
- Fireworks or smoke bombs
- Pornographic literature
- Bad language, back-talking or any other type of profanity
- Fighting or abusive behavior
- Laser pointers

Hotel is free to impose any sanctions they may deem necessary to maintain order, even to the port of the expulsion of the person/persons causing disturbances or damage to their property. Expulsion will be at the offender's own expense for any misconduct.
